On behalf of the Middle States Association Commissions on Elementary and Secondary Schools, it is my pleasure to present to you the report of the visiting team's recent evaluation of your system. We suggest strongly that you share this report with the stakeholders of your system and that you use this report to support and provide direction for your continuing work and efforts to provide the highest quality education for your students.

The enclosed team report is only the first step in a four-tiered review process that will lead to an accreditation decision by the Commissions on Elementary and Secondary Schools. This review process has been established to help ensure that Standards for Accreditation and the requirements of the protocol (the bases upon which the accreditation decision is made) are applied as consistently as possible across the Commissions' membership. Therefore, the team's recommendations may be changed, for cause, at any point in the review and decision-making process. The remainder of the review process through which your team's report will now go includes reviews by:

- The staff of the Commissions based on its reading of the team's report and the system's self-study materials;
- An advisory committee based on its reading of the team's report, the system's self-study, and the recommendations of the staff;
- The Commissions' Membership and Accreditation Committee based on the recommendations of the team, the staff, and the advisory committee.

In addition, the Commissions' policy provides you with the right to respond to the findings, conclusions, and recommendations of the team included in its report. Any response will accompany the visiting team's report throughout the review process and will be made part of your institution's accreditation file. If you decide to submit a response, please send it to the Commissions' office within 30 days of the receipt of this letter.


