The assessed value of the property which is the subject of this Appeal, namely, PIN #642481361015, consisting of 4.43 acres of land together with an industrial building situated thereon and located at 7200 Suter Road, Coopersburg PA 18036, shall be assessed at \$1,801,275, which is 100% of its fair market value, for purposes of assessment of real estate taxes for the years on and after January 1, 2013.

Spria Millennium LLC - Lehigh County File No. 2012-C-4781

The assessed value of the property which is the subject of this Appeal, namely, PIN #642471756944, consisting of 7.03 acres of land together with an industrial building situated thereon and located at 7190 Suter Road, Coopersburg PA 18036, shall be assessed at \$19,613,475 which is 100% of its fair market value, for purposes of assessment of real estate taxes for the years on and after January 1, 2013.

Attorney Jill Nagy, Special Legal Counsel for the School District is authorized to enter into a Stipulation of Counsel with legal counsel for the other parties involved in the Appeals for purposes of effectuating the Settlements.
