Board of School Directors Meeting

January 12, 2015

The first regular monthly meeting and Act 34 Hearing of the Board of School Directors of the School District of Southern Lehigh was held at 7:30 p.m. on the above date (January 12, 2015) at Southern Lehigh High School, Center Valley, PA.

ACT 34 PRESENTATION-PUBLIC HEARING-NEW ELEMENTARY SCHOOL

Mrs. Gunkle served as moderator of the hearing and provided opening remarks. Remarks included guidelines for public comments regarding the planned construction of the New Elementary School at West Hopewell Road. The Board will take visitor commends into consideration. The Board may vote on the matter of the new school plan on February 9, 2015. Solicitor Ellis H. Katz confirmed the hearing duly constituted under Act 34.

Dr. Christman commented on the project history and need for construction and alternative considerations. Mr. Josh Grice, D'Huy Engineering, Inc. and Mr. James Clough, KCBA Architects presented the project description and estimated project costs. Mr. Christopher Gibbons, Concord Public Financial Advisors, Inc. presented information on the cost analysis and budget impact.
