Elementary schools -

- We are currently in the mid-year testing process. Math common assessments are being done on an on-going basis. Mid-year DIBELS and Early Literacy Assessment testing is taking place this week.
- The K-6 Science Adoption committee has started its work of curriculum and materials review. The first meeting was held on Jan. 6.
- We are preparing for the In-service Day on Jan 17. Teachers will participate in professional differentiated development activities the including updates in math, the state's Standards Aligned System and Common Cores, and PSSA updates. In the afternoon, teachers will participate in K-12 subject area meetings.
- Hopewell had visitors from Dieruff High School on Dec. 22. They visited with Mrs. Schafer's third grade class and presented information and a power point about their native countries...Syria, Vietnam, Mexico, Columbia, & China (10 students total). This is part of Mrs. Schafer's Circle of Friends activities that focuses on student diversity.

Comverge, Inc. is a curtailment service provider who works with the electricity industry to ensure adequate power and prevent outages during unusual periods of demand. This contract permits the District to participate in the PJM Emergency Demand Response Program whereby the District agrees to a complete shutdown of all electric power in the event such a request is made by PJM Interconnection. The program has strict limitations on the hours and months when such a request can be made by PJM - generally summer hours when students are not in school. PJM Interconnection is a regional transmission organization that coordinates the movement of electricity in all or parts of 13 states and the District of Columbia. In return for the District's commitment to such an energy curtailment, the District will receive between 85% and 88% of the revenue provided by PJM to Comverge, Inc. The projected revenue stream to the District from participation in this program during the upcoming three-year period is approximately \$218,000.
