He said that this is one of four locations that the Township is considering for recreation. The Township would want access to their property through School District property. The Township is preliminarily proposing that a road be put in from the Hopewell School parking lot to their land west of Hopewell School. There was Board discussion and concerns were expressed about traffic going through the Hopewell School property. The Board said they would need more information. Attorney Bartholomew suggested that a study be done on the Hopewell property, paid for by the Township, but from the viewpoint of the School District if the Township decides to develop that property for recreation.
