# CURRICULUM/STUDENT AND STAFF ACTIVITIES

Mrs. Siegfried, Mrs. Turner and Ms. Limpar reported on student and staff activities at the High School, Middle School and the elementary schools.

Dr. Diane Keister, Director of Elementary Education and Mrs. Kathy Metrick, Director of Secondary Education presented the K-12 District 2005-2006 Assessment Summary. The vision is to create an environment, over the next three years where data analysis is used to improve student performance and increase organizational efficiencies.

The Summary displayed PSSA assessment scores for all grade levels tested, along with Special Education, for years 2002-03 through 2005-06, including comparisons with other School Districts. Two charts showed the PSSA Reading and Math results for the Class of 2007 when they were tested in grades 5, 8 and 11. The Summary also included information from the High School on Advanced Placement, Scholastic Aptitude Tests (SAT), Dual Enrollment and College classes. Implemented actions were described along with future efforts that will be utilized to insure that Southern Lehigh continues as a high performing District.
