Lehigh Career & Technical Institute

Mr. Miracle reported that 130 LCTI students participated in the Skills USA competition, with 51 winning medals. The state competition will be held at LCTI this year. He also announced that Southern Lehigh had 2 students earn student of the month last month.

Policy Committee

There was Board discussion on a \$50 student activity fee. Mrs. Auteri said the committee is still discussing an activity fee, but the fee may be illegal because School Districts are suppose to provide a free education. School Districts may assess an activity fee for activities not academic in nature such as Theater and Lacrosse. This is still an ongoing discussion item with the Policy Committee.

Mrs. Rennie reported that the Education Foundation is having a fundraising event called "Ladies Night at The Melt Restaurant" at the Promenade Shops on March 21, 2007.

Superintendent's Report

In Mr. Liberati's absence, Mr. Snell gave the following report:

- Leah Christman has started her new Southern Lehigh position as Director of Technology.
- The 2007-2008 budgets for Carbon Lehigh Intermediate Unit, Lehigh Career & Technical Institute, and Lehigh Carbon Community College are ready for our adoption. He asked the Board if they would like to have representatives from these institutions attend the next Board meeting. The Board was not interested in having any representatives come to the next meeting, but would prefer the following Board meeting if there are any questions the Board may have.
- A copy of a recent newspaper display ad from Parkland School District announcing a public hearing/adoption of a referendum question per Act 1 was handed out to the Board members. Mr. Snell asked the Board for their input on placing a similar display ad for Southern Lehigh's upcoming Act 1 public hearing/adoption of a referendum question on February 26, 2007. The School District is currently running a legal notice in the newspaper for 3 weeks, has the notice on the School District website, and would be posting the public hearing on the High School sign on Route 309 during February 20-26. The Board consensus was to have Attorney Bartholomew draft a display ad similar to Parkland's for placement in the Morning Call newspaper, and to also post the announcement through out the community at places like the post offices and the Southern Lehigh Public Library.
