Mr. Snell continued the Act 50 Property Tax Deferral Program discussion introduced at the May 7, 2007 Board meeting. He presented a summary of program activity through 2006-2007, showing the number of households and the amount of tax deferred since the program started in 2002-2003. This discussion was initiated due to the fact that Act 1 of 2006 raised the household income eligibility limitations set forth in the Senior Citizens Rebate and Assistance Act from \$15,000 to \$35,000. The eligibility of claimants for the Act 50 Tax Deferral Program is based upon household income eligibility limitations set forth in the Senior Citizens Rebate and Assistance Act. Mr. Snell presented estimates of expected additional households and expected additional taxes deferred for the next five years that would occur because the income limitation was raised from \$15,000 to \$35,000, thus making more households eligible. Estimates were given for 30, 50 and 100 additional households.

The Board felt that the Act 50 Tax Deferral Program was beneficial to lower income taxpayers, and the expected increase in the number of participants would have a negligible effect on the taxes of all taxpayers. There was Board consensus to continue the Act 50 Tax deferral program and advocated public notification of the new income limit of \$35,000. The Board requested another review of the program in two years.

Mr. Robert Breslin, project architect, explained that bids for the Intermediate School construction project came in under the Act 34 hearing figures. He explained how alternate bids stimulate competition and help keep prices down. He explained the detail bid tabulation summary and said the new school would be environmentally friendly. Mr. Thomas Busch of Snyder Hoffman explained an \$119,000 lighting system feature that will detect the amount of light coming into classrooms from outside and adjusts each row of lights so that the entire room is lit at the same level.

There was Board discussion on alternate bids, and the fact that the school will not have any windows that open and there are no removable emergency windows in the classrooms that students could use to evacuate the building if they cannot leave through the door. Mr. Breslin said he could get prices on removable emergency windows that would require a change order.
