Mr. Miracle reported -

- All modular classrooms have been removed except for Lower Milford Elementary School.

Education Committee

Mrs. Gunkle reported -

- Implementation of Read 180
 On December 14th the Middle School will have a presentation on Read 180 and then both the HS and MS will be trained on January 12th. The IS has reported that the students and teachers are really excited about the program and the preliminary results are positive.
- STEM Skill Analysis WorkKeys and KeyTrain
 There is a grant available for us to participate in these programs. Students would get a National Career Readiness Certificate if they successfully completed the program. It was agreed that we would target a group of students to participate in this pilot program.
