CURRICULUM/STUDENT AND STAFF ACTIVITIES

Mrs. Siegfried, Mr. Davidson, Mr. McGinty and Mr. Hafner reported on student and staff activities at the High School, Middle School, Intermediate School, and the elementary schools.

High School report –

- Course selection process underway. Counselors have met with underclassmen to outline process and distribute the Program of Studies book. The 8th grade parent meeting will occur on Feb. 17.
- Midterm exams were completed on Feb. 4 and teacher data analysis was turned in on Feb. 11. We are currently reviewing the data analysis and addressing any concerns that have been brought to us. Further data has been collected from teachers and individual students. We will continue to analyze the data as we always do in order to refine our practices and improve our instruction. We hope to meet with Central Office administrators to review our findings.
- Skills USA competition held on Feb. 3 at Ag Hall. We had 6 students place in the top 3 in their respective events. We are hoping to feature these students in an upcoming edition of the Laconian.

Intermediate School report -

- Students recently competed in the annual spelling bee. The winning word was surveillance. Sixth grade student Sarah Mackin was the overall winner and 5th grade student Keelin McLoughlin was the runner up. All finalists received certificates. Sarah and Keelin received free one year online subscriptions to Britannica Online and Sarah received a free online foreign language class. Sarah will go onto the Scripps Regional Bee.
- The Read-on program has begun again at the Intermediate School. For every 100 pages our students read, our sponsors will donate \$.25 to the Child Advocacy Center of the Lehigh Valley. We raised more than \$4000 last year. This year our sponsors are Lutron, Victaulic, and Altronics.
- Second marking period report cards were sent out on Friday, February 4, 2011, right on schedule despite the weather related interference.

Budget & Finance Committee

Mr. Dimmig gave the following report on the February 9, 2011 committee meeting -

Mr. Snell updated the Committee on State Basic Education Funding and Federal Edu-Jobs grants. Mr. Snell explained that SLSD had been receiving federal grants under ARRA over the past two years. Governor Corbett's administration had announced that it would be funding a shortage in the state's general education subsidy with federal funds in the form of Edu-Jobs. This would mean that the district could expect to only receive it's subsidy at prior year levels and would not receive "additional" federal funds in the future. Mr. Snell further explained that SLSD's conservative approach to budgeting had anticipated this level of funding and so the changes were already reflected in the budget.
