- Patriot Security Company chose not to renew its contract with the District because the District would not allow security personnel to carry firearms. After receiving great references, Blue Knight Security will be recommended with a contract at the next Board meeting to replace Patriot Security.
- A hand-out of the 3<sup>rd</sup> Day Enrollment figures that showed an increase from last year, but still less than 2 years ago.
- The District's position on planning for H1N1 flu will be that students need to be fever-free for 24 hours without medication before returning to school.
