## Intermediate School report -

- During the past two weeks, continued beginning year assessment has been our focus. Universal screening of all student skills has been occurring using DIBELS Next, 4Sight and Aimsweb assessments. Further, the district's first local writing assessment has been administered in all grade levels.
- Results from beginning year assessment will help to determine those students most in need of additional support that can be provided through our Response to Instruction and Intervention (RtII) and Title I programs.

# Elementary schools -

- Open Houses were held last week at Lower Milford and Hopewell, with high parent turnout. Liberty Bell's Open House is on Thursday, September 30<sup>th</sup>, 7:00 p.m.
- Our Reading Specialists and their data teams have finished their initial Fall DIBELS Testing. Intervention Groups are being scheduled and the Data Teams are reviewing the data with grade level teams as plans of action are being drafted.
- This year we have added a math screening through the DIBELS Data System. Our RtII/IST teachers and their teams are currently testing all students in grades 1-3. The testing consists of tests in Geometry, Numbers/Concepts and Algebra.
- The new School-wide Positive Behavior System at Liberty Bell is going quite well. They have received much positive feedback from parents.
- The new Digital Literacy Course for grades 1-3 is off to a great start. Parent and student response is very positive.
