  - i. The SLHS Champion Robotics Team offered a brief update of their season to the Board and public. The presentation occurred prior to the opening visitor comments. Robotics Faculty Team Advisor, Mr. Piperato opened the presentation. Students then provided updates noting that thirty students were part of the team this competition year. The team made it to regionals and qualified and competed in the world championship, placing 43 out of 77 teams. There has been an increase in student membership this year and all Seniors will be pursuing STEM majors at Higher Education Institutions. A demo was then provided by the team. Comments and questions occurred from the Superintendent and the Board.

## d. Presentation: Strategic Objectives Update

i. Michael Mahon presented the status of strategic objectives for the district. Presentation highlighted the following: implementation of Fundations, Geodes and Read Well. A new core reading program, Wit and Wisdom was selected this year and will be implemented in Fall 2023. High priority curricular projects and reviews are underway. Dual Enrollment update, potential education pathway with LCCC and CLEP testing status made. Technology and Facilities updates were provided noting that the District now has an Architect of Record in place and major maintenance projects will be occurring this summer. Operational efficiency status made and in conclusion Human Resources launched a guest teacher program this year which has improved our fill rates. Comments and questions occurred by the Board.
