- a. Education Committee: Update provided regarding secondary Math Curriculum Review: Big Ideas Learning. The Education Committee supports this and a motion will be on the November 25, 2024 School Board Agenda. A six year contract will be suggested. We are currently using this product; however, this will be a newer version. Improvements of the updated version were then made. Materials will be available to the public for review if this is approved at the November 25, 2024 Board meeting. Professional development will occur in Spring 2025 with implementation in Fall 2025. A brief summary was provided on all agenda items discussed at the November 4, 2024 Education Committee meeting. Brief overview of the HS Library renovation project was made with an update on the last steering committee meeting for this project.
- b. Facilities Committee: Louis Pepe provided a brief update regarding roof bids. Explanation for bid extensions was noted. Current deadline for bids is November 13, 2024. Extension should not impact the Summer 2025 project start dates. HVAC and exhaust systems will need to be lifted with a crane at both schools when roof replacement occurs.
