# 3. SUPERINTENDENT UPDATES

- a. Michael Mahon provided updates on the following:
  - Closely monitoring the interest rate environment and reallocation of our investments. Notation made regarding rising interest rates and impact on funding mechanisms for upcoming projects.
  - ii. Acknowledgement of today's Act 80 Professional Learning Day and Dr. Trinkle's training regarding crisis management and safety and Andria Buchman's training with our nursing team regarding intervention.
  - iii. Current Niche 2022 ranking of #17 of the best places to teach in Pennsylvania noted.
  - iv. Update on transportation made. Increased drivers now for routes.
     Situation is improving. Green slips should return next month as long as we do not have any setbacks with drivers.
  - v. Met with homecoming court last week. Over \$46,000 was raised for charity. A process will be developed between students and administration regarding participation and raising funds for charity.
  - vi. Shortage of nurses for field trips expressed. The Bayada contract will be signed tomorrow by the Superintendent and will come to the Board later this month.
    - 1. Board discussion occurred regarding communication during safety events with parents and students.

#### 4. SUPPORT SERVICES

- a. High School Mechanical Upgrades
  - i. Louis Pepe provided information regarding progress to date for the High School mechanical upgrades that are needed. Upgrades will be covered by ESSER funding, district surplus funds and loans if needed. Amount of chillers and life expectancy was outlined, along with what will be replaced. Information may appear at the 10/24/2022 Board meeting for review and vote pending that all information is received and approved by the Facilities Committee.

#### 5. BUDGET AND FINANCE

- a. Act 57 of 2022
  - Louis Pepe provided information regarding Act 57 of 2022 requiring the School District to adopt a resolution to require its real estate tax collectors(s) to waive additional charges for the late payment of real

**estate taxes in certain circumstances** beginning July 1, 2023 and each tax year thereafter. Resolution will come to the board for a vote.

- b. Universal Free Breakfast Program

Louis Pepe provided details regarding the universal free breakfast program. Start times were outlined. Breakfast schedule will go out to parents. Board discussion occurred.

i. Motion to approve the Universal Free Breakfast Program for all students enrolled at Southern Lehigh School District beginning Monday, October 17, 2022 for the remainder of the 2022-2023 school year as part of the SBP (School Breakfast Program) through a federal and state reimbursement program for each breakfast served that meets federal requirements; and

Approval of additional hours for cafeteria staff, through the 2022-2023 SY, who were previously Board approved between 3 hours and 5.5 hours per day, on a rotating basis when possible, not to surpass the Board approved 28.75 hour weekly threshold.

 Correspondence and concerns have been received regarding bathroom usage and gender identity in place of biological sex. Brief explanations of the laws were outlined, Our solicitor who was not present this evening and can address the legality of this matter at future meetings.
