SOUTHERN LEHIGH

Dear Parents/Guardians or Staff Member:

I am writing to communicate that the Southern Lehigh School District was notified of the following positive cases of COVID-19.

- **Southern Lehigh High School**
 - A student that was last physically present on 11/24/20
 - An athletic department staff member who was last physically present on 12/4/20
 - A fully remote student who has not been physically present on campus.

The Southern Lehigh School District continues to work with the Pennsylvania Department of Health in all matters related to COVID-19 and all students or staff who have been deemed a “close contact” ([PA Department of Health Definition](#)) will receive an additional correspondence from **BOTH** the **Southern Lehigh School District** and the **Pennsylvania Department of Health** with further guidance on what to do next. The Southern Lehigh School District will continue to follow the procedures outlined in the [District Health and Safety Plan](#) and specifically the [Exclusion From and Return to School Document](#). Under these guidelines, all students and staff constituting as a “close contact” will be required to quarantine for at least 14 days from the last date of “contact.” **In-person instruction under the Hybrid Model WILL CONTINUE at Southern Lehigh High School.** Under the updated PDE [Recommendations for Pre-K to 12 Schools Following Identification of a Case\(s\) of COVID-19](#), all cases that were physically present within an individual's infectious period will be added to the 14-Day Case Count and future COVID-19 cases **MAY REQUIRE** the SLHS to shift to a remote model.

Staff and students **MUST** continue to complete the [Daily Health Screener](#) and stay home when sick. Further, staff and students **MUST** notify the SLSD Nursing Team immediately if they are experiencing symptoms related to COVID-19 or are a confirmed case of COVID-19. All SLSD students and staff must continue to closely monitor themselves for any sign of illness related to COVID-19 and seek medical guidance as needed. The Pennsylvania Department of Health provides the following guidance specific to the symptoms of [COVID-19](#).
