Dear Parents/Guardians or Staff Member:

I am writing to communicate that the Southern Lehigh School District was notified of the following positive cases of COVID-19.

- **Southern Lehigh High School**
 - A student that was last physically present on 12/7/20
- **Joseph P. Liberati Intermediate School**
 - A staff member that was last physically present on 12/10/20
- **Southern Lehigh School District Central Office**
 - A staff member that was last physically present on 12/10/20

The Southern Lehigh School District continues to work with the Pennsylvania Department of Health in all matters related to COVID-19 and all students or staff who have been deemed a “close contact” ([PA Department of Health Definition](#)) will receive an additional correspondence from **BOTH** the **Southern Lehigh School District** and the **Pennsylvania Department of Health** with further guidance on what to do next. The Southern Lehigh School District will continue to follow the procedures outlined in the [District Health and Safety Plan](#) and specifically the [Exclusion From and Return to School Document](#). Under these guidelines, all students and staff constituting as a “close contact” will be required to quarantine for at least 10 days from the last date of “contact.” **At this time, the SLSD is awaiting further guidance from the Pennsylvania Department of Health with respect to in-person instruction at both SLHS and JPLIS.** Under the updated PDE [Recommendations for Pre-K to 12 Schools Following Identification of a Case\(s\) of COVID-19](#), these cases will be added to the Rolling 14-Day Case Count and bring both SLHS and JPLIS to minimum number of cases that would **REQUIRE** a shift to remote instruction for at least 3 days.

Staff and students **MUST** continue to complete the [Daily Health Screener](#) and stay home when sick. Further, staff and students **MUST** notify the SLSD Nursing Team immediately if they are experiencing symptoms related to COVID-19 or are a confirmed case of COVID-19. All SLSD students and staff must continue to closely monitor themselves for any sign of illness related to COVID-19 and seek medical guidance as needed. The Pennsylvania Department of Health provides the following guidance specific to the symptoms of [COVID-19](#).
