SLSD Parents and Guardians,

As you are aware, we needed to change from our original hybrid plan at the secondary to a fully online program for the start of the school year. We have been working to resolve issues that necessitated this decision and at this time the Southern Lehigh School District has secured the necessary staff to facilitate the physical return to school for all interested secondary students. Students who had elected for full time remote will be able to continue in that model.

Staffing challenges that exist as a result of the Families First Coronavirus Relief Act (FFCRA) will continue and so there may be substitute staffing in place to cover positions where needed. Upon the physical return to school, SLSD will have situations where District staff are completing instruction remotely to students who are physically in the secondary school buildings under the supervision of substitutes. Moving away from fully remote and into the hybrid model will present a range of challenges. We will need to be flexible and adapt daily to changing circumstances if we are to continue in a hybrid model and appreciate your support and understanding. We are implementing an education program in the midst of a global pandemic and so we may see disruptions in staffing, classes and events as we follow Department of Health guidance around exposure to and positive tests of COVID-19. Outlined below is the timeline that the District will follow for the physical return of secondary school students

- <u>Week of October 5th</u> This week will serve as a transition week for all secondary students. SLMS and SLHS will transition from the currently used fully remote schedule to a schedule that matches the Hybrid Instructional Model. All students will log into virtual classes according to the schedule provided by building administration.
- <u>Week of October 12</u> This week will serve as an in person transition for students in 7th and 9th grades who are entering a new school building. They will attend school in person on October 13, 14, & 15 according to the Hybrid Model Schedule based on last name. In school students and at home students will attend classes according to the schedule provided by the building administration.
- <u>Week of October 19</u> All secondary students who have elected in person learning will return to their assigned school buildings in the Hybrid Model Schedule based on last name.

In order to minimize changes for students, if for any reason we are forced to return to a fully remote environment, the students will follow the daily schedule outlined in the week of October 5th, which is a return to the regular school day timings.
