## SOUTHERN LEHIGH

Dear Parents/Guardians or Staff Member:

I am writing to communicate that the Southern Lehigh School District was notified of the following positive case of COVID-19.

- **Southern Lehigh Middle School**
  - A student who was last physically present on 12/10/20.
- **Southern Lehigh High School**
  - A student who was last physically present on 12/10/20.

The Southern Lehigh School District continues to work with the Pennsylvania Department of Health in all matters related to COVID-19 and all students or staff who have been deemed a “close contact” ([PA Department of Health Definition](#)) will receive an additional correspondence from **BOTH** the **Southern Lehigh School District** and the **Pennsylvania Department of Health** with further guidance on what to do next. The Southern Lehigh School District will continue to follow the procedures outlined in the [District Health and Safety Plan](#) and specifically the [Exclusion From and Return to School Document](#). Under these guidelines, all students and staff constituting as a “close contact” will be required to quarantine for at least 10 days from the last date of “contact.” **Neither student was physically present on the campus of SLMS or SLHS during the DOH defined “infectious period.”**

As a reminder, Southern Lehigh High School will be closed for in-person instruction from **December 16th through December 18th. Southern Lehigh High School will reopen for in-person Hybrid Instruction on Monday December 21st** at which time the COVID-19 case counts in the Rolling 14 Day Period will reset to zero.

Staff and students **MUST** continue to complete the [Daily Health Screener](#) and stay home when sick. Further, staff and students **MUST** notify the SLSD Nursing Team immediately if they are experiencing symptoms related to COVID-19 or are a confirmed case of COVID-19. All SLSD students and staff must continue to closely monitor themselves for any sign of illness related to COVID-19 and seek medical guidance as needed.
