I am writing to communicate that the Southern Lehigh School District was notified of the following positive or probable positive case(s) of COVID-19.

The SLSD continues to work with the Pennsylvania Department of Health in all matters related to COVID-19 and all students or staff who have been deemed a “close contact” ([PA DOH Definition](#)) will receive an additional correspondence from **BOTH** the **Southern Lehigh School District** and the **Pennsylvania Department of Health** with further guidance on what to do next. The SLSD will continue to follow the procedures outlined in the [District Health and Safety Plan](#) and specifically the [Exclusion From and Return to School Document](#). Under the updated [Recommendations for Pre-K to 12 Schools Following Identification of a Case\(s\) of COVID-19](#), cases that are noted as having been physically present (noted above) during the DOH defined “infectious period” will be added to the [Rolling 14 Day Case Count](#) for the associated school building. Under these guidelines, students and staff who are deemed a “close contact” of persons with COVID-19 will now be able to complete **ONE OF THE TWO QUARANTINE OPTIONS LISTED BELOW:**

- 7 Day Quarantine Option-** The quarantine can end **AFTER DAY 7** if the individual completes a diagnostic test (e.x., RT-PCR, antigen) where the specimen is **COLLECTED ON DAY 5 OR THEREAFTER**, the individual remains asymptomatic, and a final outcome of the diagnostic test is negative for COVID-19.
- 10 Day Quarantine Option -** The quarantine period can end **AFTER DAY 10** without the individual completing a diagnostic test if no symptoms related to COVID-19 have been reported during daily symptom monitoring.

Staff and students **MUST** continue to complete the [Daily Health Screener](#) and stay home when sick. Further, staff and students **MUST** notify the SLSD Nursing Team immediately if they are experiencing symptoms related to COVID-19 or are a confirmed case of COVID-19. All SLSD students and staff must continue to closely monitor themselves for any sign of illness related to COVID-19 and seek medical guidance as needed. The Pennsylvania Department of Health provides the following guidance specific to the symptoms of [COVID-19](#).
