Please note that the PADOH has established the following [COVID-19 School Closures Metrics](#) for the 2021 - 2022 school year. These school closure metrics are tied to the population of students and staff in each respective school building and the number of cases of COVID-19 in a school building during a 14 day period of time.

Staff and students **MUST** continue to complete the [Daily Health Screener](#) and stay home when sick. Further, staff and students **MUST** notify the SLSD Nursing Team immediately if they are experiencing [symptoms related to COVID-19](#) or are a confirmed case of COVID-19. All SLSD students and staff must continue to closely monitor themselves for any sign of illness related to COVID-19 and seek medical guidance as needed.
