- CDC, PADOH, & PDE Health and Safety Update The Commonwealth of Pennsylvania continues to see a significant downward trend in COVID-19 cases. Locally, after 28 consecutive weeks in the Substantial Classification, Lehigh County moved to the Moderate Classification at the conclusion of last week. Opportunities to secure a vaccination across the Lehigh Valley for interested individuals ages 12+ are abundant. With 10 ½ school days remaining until the conclusion of the 2020-2021 school year, the SLSD will continue to follow the Pennsylvania Department of Education's recommendation that school entities continue their current mitigation strategies in an effort to ensure consistency and minimize disruptions as a result of significant revisions to existing plans. Looking ahead, the Southern Lehigh School District continues to plan for as normal of a school year as possible in the fall.
- Track and Field District XI Meet Congratulations to the SLHS Track and Field Teams for their historic showing at this week's District XI 3A Track and Field Championships. The traditionally strong SLHS Track and Field Program had a record breaking day at the District XI Championship Meet with 2 relay teams and 3 individuals qualifying to compete next weekend at the PIAA State Track and Field Championships at Shippensburg University.
