SLSD Parents/Guardians and Staff,

Thank you to all of our students and staff who came together for a very successful first week of the 2021-2022 school year. Each of our buildings are alive with the sights and sounds of school and it is wonderful to witness our students and staff engage and interact as they work to establish the bonds that will be the foundation for an amazing school year. Further, we hope that all of the members of the SLSD community are healthy and safe following the significant rainfall that our region experienced over the last 24 hours. Weather patterns that affect school always present operational challenges, and the timing of this storm coupled with the opening week of school required a serious review of the regional road conditions. Thankfully we were able to operate with minor adjustments while still ensuring a complete first week of school. As a school community, we look forward to the opportunity that lies ahead as we continue to grow alongside one another this school year. Outlined below are some additional updates;

- Commonwealth Masking Order On Tuesday, August 31st the Commonwealth of Pennsylvania enacted an Order of the Acting Secretary of the Pennsylvania Department of Health Directing Face Coverings in School Entities. This order requires that all students and staff in the K-12 setting wear a mask. This goes into effect at 12:01 on September 7th. Because Southern Lehigh's Health and Safety Plan already required that our students and staff wear masks while indoors, the order will not significantly alter our daily routines. As a reminder, any visitors for an event or meeting are expected to wear a mask, as required by the order. Masks are not required when students, staff, or visitors are outdoors.  Communications will be disseminated for the 2021-2022 school year. This change is being made in an effort
 to reduce the overall volume of communications sent within the Blackboard Connect System which will
 help to ensure that this system is being used as intended.

 Resources. Additionally, a Blackboard Connect Message will be sent to the affected building recipients
 only.
 - Close Contact Communication Any individual who is deemed a close contact will receive a separate communication from the SLSD to denote that the individual has been deemed a close contact.

- COVID-19 Testing Resources The SLSD is currently reviewing the Commonwealth's school based COVID-19 pool testing program. The following information (<u>Press Release</u> & <u>Summary Presentation</u>) was presented at the August 23 Board of School Directors Meeting. A representative from Concentric by Ginkgo will be attending the September 13 Board Meeting to answer questions about the program. - Daily Health Screener We continue to ask that all students and staff complete the <u>Daily Health Screener</u> each day before school. Staying home from school/work when we are demonstrating symptoms related to COVID-19 is a critical step in helping to ensure that all students and staff are safe while at school.
