#### **Bond Refinancing**

Mr. Melber presented two options for the refinancing of bonds, AA of 2006 and Series of 2008.

Option 1 was to refinance both the series 2006 and 2008 bonds in January 2013. Option 2 was to wait until both series callable dates in the middle of 2013 and 2014. The difference between the two options was that the District would take on interest rate risk by waiting, and if rates were to increase, the District would lose part of the savings that were projected at the callable dates.
