- Mrs. Siegfried met with those students who will be retaking Keystone Exams beginning on December 4 - 11. Retakes will be administered one module a day, each module for 90 minutes. Literature and Biology will be done online and Algebra I will be done paper/pencil. Teacher proctors will be completing a 40 minute online training this week and the testing schedules have gone out to staff and students.

Kid Biz is our differentiated online literacy program where students are reading non-fiction articles dealing with current events at their own Lexile level.

We will also hold the first of three special "Second Grade Reading Club" events on December 6. The Read to 100 program encourages students to meet their independent reading goals.
