Retirement Recognition-Superintendent Dr. Leah M. Christman

Board President, Kathleen Parsons recognized Dr. Christman who will retire at the end of the month and presented her with an engraved rocker chair. Mrs. Parsons read the following tribute-

"Dr. Christman has been the Superintendent at Southern Lehigh since 2012. She came her in February, 2007 to work as Director of Technology. Dr. Christman taught at three other school districts for a total of 26 years. That well rounded background served her well as our Superintendent.

Dr. Christman was instrumental in bringing more technology into the classroom and more importantly, making sure teachers were comfortable using it. It's one thing to give a persona Mac or a PC, but it takes a lot more work to integrate technology into a classroom lesson and have that resource enhance studies. Some teachers needed a little encouragement than others, but the journey has been worth it.

Another passion of Dr. Christman is global education. Through her efforts our students have had teachers from China and Egypt. The district has partnered with a school in China and our students can now learn Mandarin as we as, Arabic, Japanese, Spanish, French and Latin.

Outwardly the role of a Superintendent may appear to be strictly management, but as a board member, I've found that her job was more often 'crisis management' and communications director. Whether it was finding the right words to explain to a parent that when ten inches of snow is predicted, we really to have to close schools or making sure a brand new elementary school opens on time, Dr. Christman always came through to save the day.

It has been my distinct privilege to serve as President of the Board and work closely with Dr. Christman this past year. While we all would prefer she would have stayed longer, there's no one that deserves some fun more than her. Dr. Christman, we wish you well!"
