- Auditor General's safe schools assessment received. Various recommendations
 were offered and are under review, have been corrected or will be corrected
 including expansion of drills and practices. Several items involved procedures
 that are followed but have not yet been added as part of the written manuals.

- Received notification that we are a semi-finalist for a TCLP grant through the US Department of State for an Arabic teacher for next year.
- Eddy Tang, International Programs representative for Hebei Provincial Education Department, China will visit the High School on March 12, 2012 to help set up a Chinese "sister high school". Mr. Tang will also talk to any of our teachers who would like to take part in a 23 day summer camp run by the Provincial Education Department.
