The performances on Saturday are the culmination of more than 4 months of hard work by students and their volunteer adult coaches.

- PSSA Exams begin tomorrow. There was an article in the Morning Call and the High School made the 6:00 ABC Channel 6 Evening News on their "Boot Camp".

- Southern Lehigh High School has been selected to participate in RAISE: Reading Apprenticeship Improving Secondary Education grant submitted by Mrs. Takacs. The grant was very competitive and more schools were turned away than accepted.
