# **BUSINESS AND FINANCE**

David Twaddle presented the resolution to approve the refinancing of the Series AA of 2002 General Obligation Bonds and told the board that earlier in the bond there was a competitive bond sale in which seven institutions bid on the bonds. The low bidder was Raymond James in NYC. The bond sale resulted in a present value savings for the district of 8.67%, or \$541,432.12.
