Board of School Directors Meeting

March 26, 2007

The Board met in Executive Session prior to the meeting to discuss legal and personnel issues.

CURRICULUM/STUDENT AND STAFF ACTIVITIES

Mr. Zuk, Ms. Pope and Ms. Limpar reported on student and staff activities at the High School, Middle School and the elementary schools respectively.

All three announced that PSSA assessments were completed last week with very few make-up assessments at the Middle and High Schools, and significant make-up assessments at the elementary schools due to high numbers of absences for illnesses. Ms. Pope reported that one of the three Middle School Odyssey of the Mind teams advanced to the State finals along with a High School team and a Liberty Bell team. The Pennsylvania southeast region competition was held March 17, 2007 at Southern Lehigh High School. The State competition will be held on April 14, 2007 in Altoona, PA.

Ms. Pope also said that teachers, Lynn Yocum and Ricki Stein made a presentation March 16, 2007 in New York City at the National Arts Educators national convention. They showed a PowerPoint and discussed the after school PEAK activity they run that combines art and writing. Through a partnership with the Lehigh Valley Arts Council, they bring in professional artists, poets and storytellers. The program has run for three years so far.

Ms. Limpar reported that the elementary schools held a "Go for the Green" Wellness initiative on March 14, 2007 to promote healthy eating. All food on the plates consisted of green vegetables and green fruits.

Mr. Miracle read a letter received from Victor B. Pituch, Tournament Director for Odyssey of the Mind of Southeastern Pennsylvania. Mr. Pituch thanked the Board for providing a

first class facility and a support team "second to none" in hosting the Regional Competition on March 17, 2007 at the High School. He also commended the Board for supporting the Odyssey of the Mind program that provides a platform in education for our youth to develop life-long skills.

Mr. Liberati also added that support services personnel, cafeteria personnel and administrators had done a tremendous job making the tournament a success.

Superintendent's Report

Mr. Liberati reported that a new School District Strategic Plan is due in September 2008 to the Pennsylvania Department of Education. He explained that this normally is an 18-month process if outside consultants are brought in to prepare the Plan. Mr. Liberati preferred to do it in-house and said it could be completed in approximately 8 months. The Board concurred with Mr. Liberati about preparing the Plan in-house by using District professional staff.

Mrs. Christman presented a synopsis of her March 15, 2007 report on "Initial Assessment of Technology in the District and Recommendations". With regards to the District website, she said it has the potential to be one of the most powerful communication tools available to us, and save the District significant funds by reducing printed materials through the use of electronic communications and documents. The District has applied for e-Rate funding (40% reimbursement), has completed the legal bidding process, and has selected a third party host website. She said the District is in the process of designing the site, and plan to migrate all current information on the current site to the new site in the months ahead before unveiling the new, improved website. The Board was very pleased with Mrs. Christman's report and had the following suggestions:

- · Back-up of data was not in the report, but it is recommended
- Explore the mining of PowerSchool to extract useful data
- Have Mrs. Christman review the technology planned for the new Intermediate School.
