CURRICULUM/STUDENT AND STAFF ACTIVITIES

Mrs. Siegfried, Dr. Donahue, Mrs. Farris and Ms. Limpar reported on student and staff activities at the High School, Middle School, Intermediate School, and the elementary schools.

Mrs. Siegfried reported the following -

- Teachers completed review days the week of January 18 for midterm exams. Students currently in their 2nd day of midterms and they will wrap up on January 26. Report cards will be mailed home on Friday, February 5.
- On the January 18 in-service day the HS teachers worked on evaluating their midterm and final exams for eligible content using the SAS site. They also received one hour of training on the data warehouse.
- Course selection has begun and all underclassmen at the high school have been given their course selection sheets and Program of Studies book. On Wednesday, January 27, we will hold an 8th grade parent meeting for course selection at 7:00 p.m. in the auditorium.

- Students at the Intermediate School have been busily taking mid-year assessments since their return from the holiday break. All mid-year assessment has been completed and teachers are in the process of scoring and entering data for analysis.
- Students at the Intermediate School took their first survey in January. The survey instrument was developed in effort to gain feedback directly from pupils about their feelings and experiences to date in their new school. A short summary of student survey responses is at your table.
- Teachers also took a "check-up" survey. The teacher survey was developed to seek feedback about current program and ideas for future improvement.
- The second marking period ends this week and report cards will be distributed on February 5, 2010.
- The IS and MS administration have been working together to develop a timeline for 6th to 7th grade course registration. Preliminary information has been posted on our website and will be sent home with 6th grade student report cards.
- Finally, the students at the Intermediate School are currently involved with projects aimed at raising money for the relief efforts in Haiti.
