# Budget & Finance Committee

Mr. Dimmig reported on the November 3, 2010 committee meeting -

Mr. Snell updated the Committee on the most recent changes to the five year budget since the last update in August. These included updates on healthcare cost assumptions, PSERS, revenue collections, and assumptions regarding future salary increases for teachers, administration, and support staff. The changes to revenue collections resulted in slightly less fund balance expenditure than initially forecast.

Mr. Liberati presented a comprehensive list of potential budget cuts and revenue enhancements for consideration in the 2011-2012 budget. The Committee reviewed the list and provided guidance to the administration on which items were appropriate for continued consideration and refinement.

The Committee agreed to provide a budget update to the School Board at the November 22, 2010 meeting. The Committee further recommends the board consider an Act 1 Resolution vote at the December School Board meeting.

Mr. Dimmig suggested additional Board discussion at the next Board meeting regarding the timeline for replacing business office administrators who will be retiring within the next 8 to 16 months.
