Mrs. Kristen Lewis, Director of Elementary Education and Mrs. Joan Takacs, Director of Secondary Education presented the K-12 District 2009-2010 Assessment Summary.

#### **ELEMENTARY ANALYSIS**

- We have noticed a historical dip in cohort groups between 4th and 5th grade in both Reading and Math. We also see this as a state-wide trend. We are continuing to study the issue at the student level to attempt to rectify the problem.
- This past year we saw cohort scores in Reading and Math rise from 5th to 6th grade. This may be due to the increase in time in Math and the blocking of Reading and Language Arts.

#### SECONDARY ANALYSIS

- 7th and 8th grade reading and math cohort scores increased.
- Possible reasons include:
  - 4Sight exam in math
  - The Middle School "Southpaw" Program •
  - Reading and Math PSSA Prep Courses
- 11th grade Cohort data for math and reading has shown a consistent drop. We also see this as a state-wide trend.
- Building level data teams are working at the student level to address this issue.

## SPECIAL EDUCATION ANALYSIS

We are studying why our scores continue to go down as cohort groups progress through the grade levels. We are currently looking at student level data that tracks actual cohorts. At this point our preliminary conclusion is that the results vary so widely that we will need to exam actual IEP information in order to draw any conclusions.

• It is possible that as students grow older the gap between their ability and the demands of the test is greater. However, we continue to strive to close the gap.

#### AP, SAT AND DUAL ENROLLMENT ANALYSIS

- The number of AP courses provided increased to 15.
- 385 students enrolled in AP courses with some students taking more than 1 course.
- 235 exams were administered –61% of the total enrollment took exams.
- SAT scores continue to be among the highest of the 32 surrounding districts.
- DE numbers remain the same from 2009 with 35 students taking 43 courses.
- One LCTI student received the Donnelly Award and took 3 courses at LCCC in conjunction with the LCTI program.
- 4 students chose to take college courses at DeSales and Penn State.
