



Southern Lehigh School District

Board of School Directors Meeting

March 7, 2009

The Board of School Directors of the School District of Southern Lehigh held their Annual Board Seminar beginning 8:16 a.m. on the above date (March 7, 2009) in the Southern Lehigh Middle School, Center Valley, PA.

OPENING PROCEDURES

Dr. Stelts led the Board and others attending the meeting in the Pledge of Allegiance to the Flag.

BOARD SEMINAR TOPIC

Mr. Liberati kicked off the Board Seminar With an Eye to the Future.... The Re-Creation of Southern Lehigh School District, a PowerPoint presentation explaining the bold initiatives K-12.

Mrs. Lewis spoke about how the three elementary schools will function after 4th & 5th grades leave for the opening of the new Intermediate School in September 2009. She explained how the elementary schools will have self contained classrooms K-3 with no changes to the core subjects, and intervention services without disruption to core subjects. New will be writing skills/study skills class grades 1-3 taught by reading specialist and instructional support teacher.

Mrs. Christman explained the Intermediate School Task Force recommendations, which included –

- Modified schedule for grades 4-6
- Flexibility with extended blocks of time
- Teams with 2 or 3 teachers – grades 4 & 5
- Content specific teams of 4 or 5 – grades 6
- Teachers in 4/5 teach math/science or lang. arts/social studies
- Spanish Immersion through grade 6
- Create learning neighborhoods/communities
- Establish an environment to support the developmental and diverse needs of students and emphasize relationships between students and teachers.

Mrs. Farris presented the following schedule design recommendations for the Intermediate School –

- 90 minute core instruction: math, lang. arts, science/social studies – allows focus and flexibility
- Related arts – traditional and future focused
- “Enrichment and Focus” promotes music program and differentiated support
- Full Spanish immersion experience through grade 6
- Math acceleration in grade 6.

Mr. Bergey reported on transportation benchmarks for the Intermediate School. The proposed school day will be 8:50 AM to 3:30 PM, with buses arriving at 8:45 AM.

Mrs. Takacs reported on the 7-8 Building Task Force recommendations that included retaining –

- The Middle School philosophy
- Teaming approach – collaboration
- Introductory/exploratory in related arts
- Students activities

- Band/chorus/theatre productions
- Visual arts

And renovating –

- Schedule to allow more instructional time
- Foreign language/related arts
- Investigate virtual learning
- Reinforce MS philosophy
- Time for tutoring support
- Technology courses moved from HS to MS

Dr. Donahue presented the Middle School schedule design highlights –

- 50 minute core instruction by teams
- 6 day cycle
- Homeroom absorbed into period 1
- Activity period – 2 out of 6 days
- Related arts teacher – 6 period day (5 at MS; 1 at IS)
- Advanced Spanish for Spanish Immersion
- Math acceleration retained
- Year-long Spanish I – 8th (moved from 9th)
- Applications of Technologies – 8th (moved from 9th)

Mrs. Siegfried talked about what is new at the High School –

- Applications of Technologies to MS – remains also at HS for 09-10 then phased out
- Spanish I to MS – continue to offer at HS
- New courses for 09-10 – AP Psychology, Electronic Music, Piano I, Theatre I (updated from Drama course), Dual Enrollment for College Algebra and Public Speaking
- Investigation for math courses – Honors Alg. II & Pre-Calc.

Mrs. Christman reported on the items in progress/research for curriculum development/revisions –

- 21st Century skills
- Virtual critical language – Chinese
- World language/Spanish Immersion
- Need to develop curriculum for additional areas.

Mr. Liberati explained staffing movement and new staff needed –

- 4 elementary teachers move to IS – Art, Music, Librarian, PE
- Technology Education teacher from MS to IS
- PE/Health teacher from MS to IS
- Related Arts teacher at MS to teach 1 period at IS each day
- Guidance Counselor from MS to IS
- Psychologist from elementary school to IS
- Learning Support moves from elementary & MS to IS
- 7 new teachers District-wide.

The Board took a brief recess, and the meeting reconvened 10 minutes later.
