#### 2011-2012 BUDGET DISCUSSION -

Mr. Snell presented a 5-year budget that was revised since the Budget Seminar on March 12. The 5-year budget at March 12 included the Governor's proposed cuts to education subsidies.

Revisions to the 5-year budget included the following for 2011-2012. The good news -

- The reduction in the state's reimbursement for social security from 50% to our aid ratio rate of about 17%-18% would apply only to employees hired after 1994.
- Overall increase in health care costs lowered to 6.0% from 8.5%.
- Cumulative decrease of \$84,000 in support for LCCC, CLIU and LCTI.
- Increase in real estate tax revenue of about \$150,000 \$160,000 due to Avantor moving its headquarters to Stabler Center in late summer/early fall.
- A slight increase in real estate transfer tax.

The bad news -

- A reduction in the growth of real estate tax base from 2% to 1%.
- A slight decrease in delinquent tax collection.
- A decrease in the estimated Act I index for the next few years.

In summary for 2011-2012 budget, Mr. Snell said that only \$56,000 in variances (things that break our way) remain from the original target of \$500,000, and no further spending reductions are required to meet Board parameters established at the September 13, 2010 Board meeting.
