 - 1. Did not have monthly meetings (discrepancy from SDIC's requirements)
 - 2. All listed members were not trained
 - 3. Did not have a quorum when we met

Suggestions to become compliant moving forward:

- Monthly meetings
- 2. Limit members to 9-11, with majority working 12 months/year

The committee discussed how to become compliant - it was decided that we would move the meetings to the second Thursday of each month so that we have two alternate dates if the meeting needed to be cancelled and limit the "trained" members of the committee to 9 persons. The meeting is open to anyone who would like to attend and we will list those people as Attendees only. We have the opportunity to retain the certification by resubmitting our application with the necessary changes by Nov 14th.
